GGL 認証は、持続可能なバイオマス燃料とそのトレーサビリティを担保する国際認証であり、日本においては、再生可能エネルギー固定価格買取制度（FIT 制度）に係る事業計画策定ガイドライン（バイオマス発電）で定められた第三者認証のひとつです。同ガイドラインにて、FIT 制度対応のバイオマス発電所向けに PKS を供給するにあたり、持続可能性（合法性）を確保し、2024 年 4 月以降（予定）から第三者認証が必要と定められています。

当社が供給する PKS は、この GGL 認証のルールに従い適切な供給過程を証明するものになります。

当社は、グループ会社である HUMAN & ECO ENERGY RESOURCES DEV' T (M) SDN BHD と PT BIOMASS FUEL INDONESIA と連携を取り流通過程での一貫した管理を徹底し、持続可能な PKS の供給を行ってまいります。

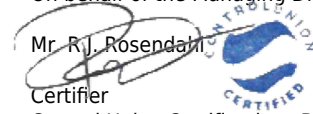
